## RULES

- All classes will be run in accordance with Pony Club Eventing Rules 2017.
- In the event of cancellation, £5 of each individual entry will be retained to defray expenses.
- Team organisers must declare their teams one hour before their dressage time and present their team at the appropriate time for tack inspection.
- Dogs must be kept on a short lead at all times.
- All litter to be taken home, and no trailers/lorries to be mucked out on site.
- The Judges' decision is final.
- **Remember: Current standard** Hats are mandatory with White Tags. Spur Permission cards, Number Bibs & Body Protectors, **The Beta 2009 Level 3 (purple) tag** are all compulsory. **THE BETA 2000 PURPLE TAG IS NO LONGER PERMITTED.**
- Medical Arm Bands are advised.
- Numbers will be provided in A4 format for insertion into bibs..
- Competitors are deemed to have read and understood the 2017 rule book.
- Outside Assistance and failure to follow safety guidelines will result in disqualification.
- The Judges' decision is final. Objections may only be made by the appointed Branch Representative and must be lodged with the secretary in writing with a deposit of £25 within 15 minutes of results being posted. Any appeal will be listened to by the Jury of Appeal.
- The Organisers reserve the right to alter or amend any aspect of the competition.
